Emergency Nurses Association turns 50!

Introduction

As Emergency Nurses we use a combination of education, training, daily practice, and procedure to consistently be our best. For all of us this year, we might have found ourselves searching for information or resources on how to best deal with an unexpected pandemic. One key component to that information needed, especially in these changing times, is the global Emergency Nursing community and the many invaluable resources it provides us.

As a practicing Emergency Nurse in the Netherlands and current board member of the ENA, I have seen the value of partnerships between the Emergency Nurse organizations, chapters and societies come to together to mobilize and overcome those unexpected challenges. Not just with encouragement, but by providing life-saving resources that brings subject matter expertise to our practice and profession. It has also shown light on the global reach of our profession and the need now, more than ever, to partner with one another as we seek to grow, learn, and become stronger. As ENA celebrates it's 50th Anniversary, we see the next 50 years as an opportunity build on our global partnerships.

International Mission

Built into our mission at ENA, is the commitment to developing international partners and to further developing the emergency nursing community worldwide. Our partnership with EUSEN and other associations worldwide, allow for those resources to be shared, for cross cultural learning, and joint efforts to identify and develop resources to meet those growing needs. At ENA, we view international partners, such as with EUSEN, as a collaborative way to address needs and get resources back into the hands of our nurses. ENA has recently invested in furthering our international partnerships with the addition of staff, who are dedicated to ENA's international development. These new staff members are focused on reaching out to international Emergency Nursing organizations in other countries, creating greater awareness of the educational resources available through ENA, and building partnerships worldwide that elevate the Emergency Nursing community.

International Resources

When COVID-19 began to become a worldwide pandemic, ENA created an entire webpage resource

guide dedicated to keeping the EN community up to date with the most current information. One key resource on that page is our new 'Micro Bytes', which are short micro learning videos to educate EN's on COVID-19 topics. These short videos can be easily accessed via a portable smart device and allow to 'learn on the go'. : <u>https://www.ena.org/practiceresources/covid-19</u> and go to "COVID BYTES" on this page, accessible for non ENA members as well. On this page there are also a lot of other resources related to COVID to be found.

Access to information in a consistently changing environment can be a challenge. ENA's goal is to help provide more information and resources to the EN community, that is easily accessible, when you need it, and where. This is why we continuously creating a resource library of educational tools, podcasts, research, educational content and even providing a yearly EN conference – that lives on through our 'Conference on Demand' platform, to meet your resource needs...wherever you might be in the world.

New Developments

As ENA builds stronger relationships around the world, we are able to advance the EN community by bringing educational content to new audiences. We have numerous initiatives that are currently under way and being developed, as a result of our outreach and response to such educational needs.

Currently ENA is working with a partner in Poland to bring the ESI Triage course and education to 200 plus hospitals and over 1,000 polish nursing students throughout Poland. This opportunity is through the country's Ministry of Health, and an effort to provide a standardization for triage.

We are also proud to offer the same ESI course in a translated Spanish version. The ESI Adult Learning course has been updated with a new learning format that creates a rich learning experience.

With new parameters in place for COVID-19, ENA has been able to pivot and offer a virtual TNCC and ENPC model, allowing instructors to provide this advanced trauma nurse course virtually. ENA currently has TNCC and ENPC partners in 19 different countries, and we are working to expand that reach. We have also started to provide the TNCC and ENPC courses in multiple languages, with translations into French, Spanish and Dutch.

ENA is currently working on opportunity to work with a local partner in the India market. This new endeavor will provide access of our educational content and resources to hospitals and nurses throughout India, and eventually to the Middle East and Southeast Asia Markets.

This year, as many conferences were being canceled, ENA made the decision to pivot and offer a virtual annual conference. On 9-11 September, Emergency Nurses worldwide signed in and tuned in for three days of general assembly, educational sessions, and networking events designed to provide a 3-D experience while attending virtually. This was a first for ENA, and allowed for participants worldwide, given the virtual format. While nothing replaces the face-toface meetings and interactions, this new virtual approach did allow for attendees to join in, who otherwise would not be able to attend due to travel restrictions. After the initial session in September 3 so call "Encore days" were held, giving additional education about specific topics, like resuscitation, diversity and inclusivity and legal and forensic aspects of emergency Nursing.

Commitment to the Next 50 Years

Whether it is organizing a global conference, providing scholarship funds to nurses to attend our conference through the ENA foundation, developing resource guides available on our website, holding monthly international advisory council meetings, or establishing relationships with our partners worldwide, ENA is committed to not only the EN community, but also to the associations that support and hold that community together.

In the months and years ahead, ENA looks forward to partnering with EUSEN, and other EN associations, to meet those unforeseen challenges and band together to overcome, to learn, and to grow. In the spirit of our 50th Anniversary and to quote our original co-founders of ENA, Judith Kelleher and Anita Dorr, I leave you with the following inspiration: "In the inclusion and contributions of nursing, in collaboration with healthcare partners worldwide, to explore innovative solutions to the challenges of emergency care delivery".


